

## TERMS AND CONDITIONS FOR USE OF OUR WEBSITE

Please read these terms of service before using this website as it applies to your usage of this website offered by Construction Guide, INC. (“Construction Guide,” “we” or “us”). Clicking the “Agree” or “Accept” button (or otherwise affirmatively agreeing to these Terms, as applicable) or visiting the Site in any manner, shall be considered acknowledgement by you, the end user (“you,” “your” or “User”) that you have read and agree to be legally bound by and a party to, without modification, the Terms detailed herein. If you are an individual seeking to use the services of Construction Guide (“Services”) on behalf of your employer or another entity, you represent and warrant that you have the authority to agree to these Terms on such entity’s behalf. All references herein to “you,” “your” or “User” shall include such entity. If you do not unconditionally agree with or accept these Terms, or any posted guidelines or rules, or you do not have the authority to bind your employer or applicable entity, you must not use the Site or the Services. Use of the Website is expressly conditioned upon your assent to all of the Terms, to the exclusion of all other terms. Certain Services may be subject to additional terms and conditions, to which you must agree.

Construction Guide may, at its sole discretion, modify or revise the Terms at any time by updating this page. These Terms, and any rights and licenses granted hereunder, may not be transferred or assigned by you, but may be assigned by Construction Guide without restriction. ### I. Registration

Each party to any suit, action or proceeding arising out of or relating to these Terms irrevocably (i) submits to the jurisdiction of the State Courts of the State of New York and the United States District Court for the district of Southern District of New York over any suit, action or proceeding arising out of or relating to these Terms, (ii) waives to the fullest extent enforceable under applicable law any objection which it may now or hereafter have to the above venue of any such suit, action or proceeding and any claim that any such suit, action or proceeding brought in such Court has been brought in an inconvenient

forum, (iii) waives to the fullest extent enforceable under applicable law any objection which it may now or hereafter have to the above mentioned Court having jurisdiction of the parties hereto and to the subject matter of these Terms, and (iv) acknowledges that a final judgment in any such suit, action or proceeding brought in such Court, after all appropriate appeals, shall be conclusive and binding upon it. In any suit or arbitration regarding these Terms, the prevailing party shall be entitled to reasonable attorneys' fees and costs.

We reserve the right, in our sole discretion, to modify or replace any of these Terms, or change, suspend, or discontinue the Site (including without limitation the availability of any feature, database, or content) at any time by posting a notice on the Site or by sending you a notice through the Site, via e-mail or by another appropriate means of electronic communication. We may also impose limits on certain features and services or restrict your access to parts or all of the Site without notice or liability. While we will timely provide notice of modifications, it is also your responsibility to check these Terms periodically for updates. Your continued use of the Site following notification of any changes to these Terms constitutes acceptance of those changes.
